

Christmas Pick A Present Promotion

Terms and Conditions

PROMOTIONAL PERIOD

1. The Christmas Pick A Present (the **Promotion**) commences on 25 November 2019 and concludes 6 December 2019 (the **Promotion Period**).
2. The prize draw will take place on each day, at 8pm during the Promotion Period 25 November to 6 December at Highways.

ELIGIBILITY

3. In order to participate in the Promotion patrons must not have been excluded from any Pegasus Leisure Group venue (whether by self or otherwise).
4. By entering or participating in the Promotion each eligible participant agrees to abide by these terms and conditions and the Pegasus Rewards Membership Rules (to the extent that such entrants are Pegasus Rewards Members).
5. Employees, management and licensees of the Victoria Amateur Racing Club (incorporating the Melbourne Racing Club) (the **Promoter**), its related parties and their families are ineligible to enter the Promotion.
6. The Promoter may determine in its absolute discretion the eligibility or ineligibility of any person.

ENTRY REQUIREMENTS

(A) Pegasus Rewards club members

DAILY KIOSK SWIPE

7. Pegasus Rewards Club members will receive one entry daily when they swipe their membership card at the member kiosk at Highways. Each member will be able to receive a maximum daily kiosk swipe entry of one per Venue visited per day. Entry will print automatically into the ticket spitter located in venue.
8. Upon joining as a Pegasus Rewards Member during the Promotion Period, the new member will receive 1 entry in respect of the Venue in which they have become a member.

IN EGM

9. Pegasus Rewards Club members will automatically receive the following entries each time they insert their membership card in any electronic gaming machine card reader. Each entry will be printed directly into the official entry barrel located in venue:
 - a. CRYSTAL MEMBERS -5 entries
 - b. PLATINUM MEMBERS – 3 entries
 - c. GOLD MEMBERS – 2 entries
 - d. SILVER MEMBERS – 1 entry
10. Members are under no obligation to game or turnover any minimum spend in order to participate in the Promotion.

ENTRY VIA IN VENUE CASH PURCHASES

11. Pegasus Rewards Club members will receive 1 official entry into the Promotion each time they make a cash purchase in any food and beverage outlet (of any value) at Highways (up to a maximum of 2 entries per day).
12. Pegasus Rewards membership cards will need to be swiped to be eligible – it is the responsibility of the member to present their membership card at time of purchase.
13. All entries will be automatically printed into the official entry barrel.

THE DRAW

14. Daily draw to take place each day during the promotion Period at 8pm
15. Winner must be present at time of draw to win a prize.
16. The person drawn, will select a present box which will reveal a card showing the prize won.
17. Patrons can be drawn more than once during the Promotion Period.

THE PRIZE OR PRIZES TO BE WON
